# **Hanbury Trust**

The Hanbury Charity has been in existence since around 1760 and is overseen by volunteer trustees from within the Langton villages. The number of Trustees has dropped to a critical level and the charity is seeking a nomination from Tur Langton. The website is:

The Charity's primary function is to grant assistance to young people living in the Langtons and surrounding areas who are in need of financial support in order to continue with their further or vocational training. The charity also supports Church Langton Primary School by in excess of £20,000 per annum and were the major contributor to the artificial pitch.

For at least the last two years no eligible person from Tur Langton has applied for an education grant but a number of children from the village will have benefited from the support given to the school. One of the tasks of a nominated Trustee is to champion the Charity in the parish and form a local point of reference for possible applicants, so having a local Trustee would help to promote the grant in the village. The workload is not great but there are one or two small committees that need strengthening and new Trustees are required for new ideas and overall succession. Much of the day to day matters can be handled by email and if need be by video contact.

The Chair of the Charity, Derek Hewitt, would be happy to talk to anyone interested in becoming a Trustee and to answer any questions. A copy of the Charitable Scheme is available from the Parish Council Clerk. If you are interested, please contact the clerk in the first instance.

#### Libraries

Click and Collect was launched at 11 out of 16 County Council run libraries on 6th July (including Market Harborough for South Leicestershire), and at Blaby library on 13th July. Customers can request online or by phone.

#### Waste Recycling Centres

Kibworth will re-open on Monday, 3rd August with online bookings from Friday, 24 July. Market Harborough, waste site will continue to be open for the extended seven days a week for now, but this will gradually change as more sites re-open through August. All sites require residents to book an appointment in advance online, to ensure social distancing can be maintained.
