## EV Charging at the Village Hall

The Village Hall Committee would like to know if there is any interest in the village for one or two EV

charging units at the Village Hall. ## Bus Service FoxConnect

The 44 Bus service has been changed to the LC44. As part of the process the Langton's branch has been removed from the service. The County has replaced this with the FoxConnect service. This is a bookable bus service that can either ordered through the (Leicestershire FoxConnect' with the white background) or by telephoning 0116 216 7756 (Mon Sat 8.30-16.30). Currently you can order this service to take you to: Market Harborough St Lukes, the centre of Market Harborough and the railway station; Uppingham town Centre, Houghton-on-the Hill centre; as well as the other villages in 'Zone 5'.



The Service will run Monday to Saturday 06:00 to 19:30, is a card only payment on boarding (or in advance if using the app). Journeys can be booked 7 days in advance and up to 45 minutes before desired time of travel.

The Langton Parish Councils met with two of our local County Councillors, Kevin Feltham and Barry Champion to discuss the issue with the current lack of public transport to the Kibworths. It is proposed that the Kibworths will be

added in as a new destination, in the same way as Market Harborough, Uppingham and Houghton on the Hill currently are for Zone 5. The county will be monitoring the fox connect service usage over the next 3 months as a trial period, so it is possible that this re-connection may not occur until after this 3 month period.

We urge as much use as possible of the new service over the next 3 months as it will determine the county's current planning for this service. If anyone needs help with using the app then please contact either Clare Staveley or Tessa Bladon.

## Community Grant Scheme

Tur Langton parish has the opportunity to apply for up to £5000 of a total share of a £40,000 allocation for smaller villages in the Community Grant fund. There will be 32,538.00 of this fund remaining if all current projects are agreed at the Cabinet Sub-Committee Grants meeting on 18 March.

Tur Langton is currently looking at putting in Electrical Vehicle charging units at the village Hall and getting more equipment for the table tennis club. If there are any other community groups that would be interested in receiving funding: Round three is opening to applications on 25<sup>th</sup> March until 19<sup>th</sup> May.

### Dog waste bins

Further to the previous newsletter with regards to the installation of dog waste bins, It has been established that they will need to be located on highways land so that they can be easily accessed for emptying.

The cost of installation and the ongoing costs for weekly emptying bins would be paid for through an increase in the precept next year.

Six potential locations associated with the village's footpaths have been identified.

Correct location of the bins is important and we need your help to get it right.

Proximity to houses, needs to be considered, as well as whether they will be in direct sunlight for significant proportions of the day creating unpleasant odours.

- is a less frequented footpath, but not near a house, but is south facing
- 2. is on the roadside by the village hall, near the memorial garden and south facing
- 3. is on the roadside by a grade II listed house, south facing
- 4. is near the bench, but a current hotspot for waste bags, north facing
- 5. is in a sheltered location, less frequented footpath but near a
- is by the stile on a frequently used footpath but visible from the houses opposite and on the main road so may attract additional waste.

Installing bins will not be a quick process. It involves, applying for planning permission, obtaining

# County News Harborough District Local Plan - Consultation

The public consultation on the Proposed Submission Draft Harborough Local Plan 2020-2041 (Draft Local Plan) and supporting documents starts on Monday 10th March and will run until Tuesday 6th May 2025 in accordance with Regulation 19 and 20 of the Town and Country Planning (Local Planning) (England) Regulations 2012. All links will be live from 9am on Monday 10th March.

The Draft Local Plan covers the whole administrative area of

the period between 2020 and 2041. It sets out a strategy for the amount, location and design of new built development (such as homes, schools, employment and retail) in a way that helps to ensure the vitality of communities, protect the district's rural character and unique built and natural heritage, as well as improve the natural environment and tackle climate change.

This consultation is an essential stage of Local Plan preparation. It represents the final opportunity to comment on the Draft Local Plan before it is submitted to the Secretary of State for Examination. You can view the main documents
